text message involving yourself being mentioned in it and Deputy [REDACTED] and [REDACTED] [REDACTED] Do you know what text message I'm talking about?

[REDACTED] Yes, sir.

[REDACTED] All right. Did you ever see the text message?

[REDACTED] No, sir, I never saw the text message.

[REDACTED] Were you ever sent the text message?

[REDACTED] No, sir.

[REDACTED] All right. Tell me how you found out about the text message.

[REDACTED] I was told by I want to say it was Deputy [REDACTED] He told me that a text was, I believe if I remember correctly, he told me a text was sent to [REDACTED] And what was on that text that was relayed back to me. I believe that was what who told me.

[REDACTED] And what was your understanding of what the content of the text message?

[REDACTED] That me and Deputy [REDACTED] were having a sexual relationship with Deputy [REDACTED] at the same time. And I think it also mentioned that she had some sort of sexually transmitted disease, herpes I think.

[REDACTED] Something like that.

[REDACTED] And so your recollection is that Deputy [REDACTED] told you about this.

[REDACTED] Yes, I believe it was him.

[REDACTED] And what did he tell you that you had been specifically mentioned in the message? Is that why he told you?

[REDACTED] Okay. And what did he tell you if he knew who sent the message?

██████████ No. I don't think he knew who sent the message. It was an anonymous text, the phone number. But he didn't tell me who text. He didn't know who the text message was from.

██████████ Did he tell you who he suspected sent the message?

██████████ Yes. I think we all kind of suspected the same person sent the message.

██████████ And who is that?

██████████ Deputy Mandoyan.

██████████ And why would you suspect that he sent the message?

██████████ Because there was an ongoing issue between him and Deputy ██████████. And I think that they had exchanged words, things had been said, and she was suspecting that it was him sending from an anonymous phone number to cause issues for her at work.

██████████ Okay. And did you ever work with Deputy Mandoyan?

██████████ I never worked with Deputy Mandoyan.

██████████ Okay. Did he ever work up here at Universal working overtime or anything?

██████████ Not while I was here, but I think he had worked up here a couple times.

██████████ Okay.

██████████ But I never worked with him.

██████████ Is there any reason why he would include you? Do you think he was targeting you or, I mean, what's your thoughts on why he would send that message?

██████████ I'm not even sure why he would send out a message like that. I'm not sure if it was his issues that were with Deputy ██████████. I don't know it was to cause her problems here at work, but maybe he thought that there was something going on between us because we were, you know, we worked up here on a daily basis in a small unit, so we were a close unit. We'd have lunch together, dinner together, so forth. And, you know, we got along and worked with each other. So I'm not really sure why he would send out that message but that's his own problem.

Did you ever talk to Deputy Mandoyan about this message?

I've never discussed anything with him.

██████████

Okay. And did you discuss it with Deputy ██████████

██████████

Yes, I did.

██████████

And what did you two discuss or what was mentioned in that discussion?

We just discussed that, you know, we both thought that it was him as well. And she was just not sure why he was sending that message out either, nor was I. But I know she just was having issues with him. She definitely showed she was very afraid of him and who he was. And the things that he could possibly do to her, so forth.

What did you know about their relationship like how long were they together? Do you have any idea like from what time to what time?

I don't know what the dates were. I know they were dating for a while and...

For like a few months? A year?

██████████

I was on training. As far as I know from probably just, from what I remember they were on training. When I was there they were still together on training, but I couldn't even tell you how long they were dating.

Okay. Are you aware of any point when they actually broke up?

██████████

No. No, because she was IOD for quite a while so I wasn't sure when they broke up. And then she just came back.

And what was your understanding of ██████████ and Mandoyan's relationship when this text message came out?

██████████

They weren't really talking at all. They weren't together.

Okay.

██████████

As far as I know. I'm not sure as far as the just of the relationship but I don't think they were dating at that time.

Was there anything that you can recall that may have triggered or was there something specific at the time this text message went out that may have triggered this thing to be sent out?

No, not that I can say. There was nothing that I would think that would trigger that. We just, I don't, all I'm assuming is, you know, he just saw that we were friends and thought that there was more going on then there really was.

Okay. And did, roughly how long did you work with Deputy

About a year.

And was that all up here at Universal?

Yes. Actually, no, I am sorry. I worked longer than that because I was down at the city when I was on training and she was there. So I probably worked with her for like a year and a half.

Okay. And in your time either down in West Hollywood or up here at Universal City, would there be occasions where Deputy would be on-duty and Deputy Mandoyan would either come up here or down in city to meet her while he was off-duty?

I saw him a couple times at the station while she was working. I'm not sure what at that time. I really, I was on training so I didn't really bother with their relationship. But I did see him at the station a couple times while she was working down there he would stop by.

All right. And was your understanding when you would see him that at that point they were dating?

Yeah, at that point, yeah. My understanding was that they were. People thought that they were in a relationship.

And were you, did you ever see him up here at Universal?

I personally never saw him up here at Universal.

Okay. All right. Now that I've asked you about this, is there anything that you can tell me or anything that comes out that maybe I haven't asked you related to their relationship and any issues going on between them and then involving this text message?

██████████ I know Deputy ██████████ she was very afraid of Deputy Mandoyan for whatever personal reasons they had going on in their relationship. I'm not sure why he was targeting our names being thrown out, mine and Deputy ██████████, ██████████ as well. But she just was, she was very, she made it out that she was very scared. Whatever was going on, whatever had happened in their relationship in the past, she wasn't a very, she wasn't too fond of what had happened or what was going on in that relationship.

██████████ Did she ever explain to you what caused her to be scared of Mandoyan?

██████████ She told me it was one instance in particular that he had broken into her house when she wasn't there and it was caught on video. She had video surveillance at one point. And that he had shown up to her house a few times and there was some other physical altercations during the relationship that he had done to her while they were together.

██████████ Did she get into any specific details about physical altercations?

██████████ She just said he had put hands on her before while they were in a relationship. Other than that I don't know whole details of it, but she just told me stuff like that, those minor details. She didn't want to go into the entire details of the relationship.

██████████ Would she, when she would tell you some of these things was it like right after the incident happened or was this like after the relationship?

██████████ This was after the relationship. This was way after the relationship. The relationship was already over.

██████████ Okay.

██████████ In the past it had happened. And during the...

██████████ While they were together.

██████████ Right. It was while they were together.

██████████ Yeah. It wasn't, she wasn't telling you about these incidents while they were together? I just want to be clear on that.

And this was stuff that happened during their relationship.

I know definitely ██████████ doesn't either. So I'm not sure why that text message was sent out in regards to that, couldn't tell you to be honest.
